#### Peterborough Holiday Voucher Scheme - Easter Holiday

Peterborough City Council will be continuing its holiday voucher scheme for the Easter Holiday using funding by the Department for Work and Pensions via the Household Support Fund. It was announced last week that the Household Support Fund will be extended for a further six months. Further updates will be shared once the Council receives them.

Appendix 1 of this letter outlines the different income related eligibility criteria based upon a child's age. For eligible young people attending sixth form colleges/further education establishments, information on how support will be offered will be sent directly by the college.

Details of how to apply for income related Free School Meals, if you have not already done so, can be found <a href="https://example.com/here">here</a>. There is a <a href="mailto:simple application form">simple application form</a> which only requires a few details and will instantly check if you are eligible. Each successful application will also bring up to £1,500 additional funding for your child's school.

For the Easter holiday, our scheme will operate as follows -

- We will issue each eligible child/young person with a £30 voucher via email and/or text. This will be sent on **Saturday 30<sup>th</sup> March**. You will be able to choose from eleven different supermarkets.
- Vouchers may take until 9pm on Saturday 30<sup>th</sup> March to arrive. If you haven't received your voucher by Sunday 31<sup>st</sup> March please contact us. Please include your child/ren's name and their school/ setting in your email.
- Any children who become eligible up until the 12<sup>th</sup> April will also receive vouchers. These will be sent when we are notified of newly eligible children by our Education Welfare Benefits Team.
- Details of the supermarkets which will accept the vouchers and how the voucher scheme works can be found in the frequently asked questions document sent with this letter.
- All vouchers must be claimed by 3pm on Friday 12th April 2024. If unclaimed, we are unable to reinstate them after this date. This is a shorter timeframe than previous rounds due to reporting deadlines for the Council that have been set by the Department for Work and Pensions.
- If you **do not** wish to receive the food vouchers, please let your school or setting know as soon as possible so that we can reallocate them.

# Appendix 1 – Eligibility for Direct Voucher Scheme

Parents eligible for Funded Childcare and Education for 2-year-olds under the income-based criteria

In order to qualify you must be in receipt of one of the following benefits:

- Income Support
- Income-based Jobseeker's Allowance (JSA)
- Income-related Employment and Support Allowance (ESA)
- Universal Credit, and your household income is £15,400 a year or less after tax, not including benefit payments
- Tax credits, and your household income is £16,190 a year or less before tax
- The guaranteed element of Pension Credit
- The Working Tax Credit 4-week run on (the payment you get when you stop qualifying for Working Tax Credit)

<u>Parents eligible for Early Years Pupil Premium under the income-based</u> criteria

In order to qualify you must be in receipt of one of the following benefits:

- Income Support
- Income-based <u>Jobseeker's Allowance</u>
- Income-related Employment and Support Allowance
- Support under part six of the Immigration and Asylum Act 1999
- The guaranteed element of <u>State Pension Credit</u>
- <u>Child Tax Credit</u> (provided you are not also entitled to <u>Working Tax Credit</u>) and have an annual gross income of no more than £16,190
- Working Tax Credit run-on, which is paid for 4 weeks after you stop qualifying for Working Tax Credit

 Universal Credit - your household income must be less than £7,400 a year after tax not including any benefits you get

Parents eligible for Free School Meals (children and young people aged 4 to 16)

In order to qualify you must be in receipt of one of the following benefits:

- Income Support
- Income-based Jobseeker's Allowance
- Income-related Employment and Support Allowance
- Support under Part VI of the Immigration and Asylum Act 1999
- The guaranteed element of Pension Credit
- Child Tax Credit (provided you're not also entitled to Working Tax Credit and have an annual gross income of no more than £16,190)
- Working Tax Credit run-on paid for 4 weeks after you stop qualifying for Working Tax Credit
- Universal Credit if you applied on or after 1 April 2018 your household income must be less than £7,400 a year (after tax and not including any benefits you get)

Children who get paid these benefits directly, instead of through a parent or guardian, can also get Free School Meals.

### Eligible for 16-19 Free School Meals

Students must be enrolled in Further Education provision funded by the Education Skills Funding Agency and be in receipt of, or have parents who are in receipt of, one or more of the following benefits:

- Income Support
- Income-based Jobseeker's Allowance
- Income-related Employment and Support Allowance (ESA)
- support under Part VI of the Immigration and Asylum Act 1999
- The guaranteed element of State Pension Credit
- Child Tax Credit (provided they are not entitled to Working Tax Credit and have an annual gross income of no more than £16,190, as assessed by Her Majesty's Revenue and Customs (HMRC))
- Working Tax Credit run-on paid for 4 weeks after someone stops qualifying for Working Tax Credit
- Universal Credit with net earnings not exceeding the equivalent of £7,400 per annum (after tax and not including any benefits you get)

#### Other Eligibility

Children in care are not covered by the scheme as the costs of meals in the holidays are covered by fostering allowances.

and the definition of a child is any person:

- under the age of 19 as at the 30<sup>th</sup> March 2024
- aged 19 or over in respect of whom a child-related benefit (for example Child Benefit) is paid or Free School Meals are provided
- aged 19 to 25 and have an EHCP and accesses the bursary scheme or free school meals in their college.

#### How to Claim Free School Meals

- Income Support.
- Income-based Job Seeker's Allowance.
- Income-related Employment and Support Allowance.
- Child Tax Credit but no element of Working Tax Credit and have an annual income (as assessed by HM Revenue and Customs (HMRC)) that does not exceed £16,190.
- If you are supported under Part VI of the Immigration and Asylum Act 1999.
- Guaranteed element of State Pension Credit.
- Working Tax Credit during the four-week period immediately after your employment finishes or after you start to work fewer hours per week.
- Universal Credit with an annual net earned income of no more than £7,400.
